### REPORTS OF THE SUPERINTENDENT

A. School Facilities Update: We are close to completion of the high school closeout. Work is continuing on the PK-8 closeout list. The district met with OFCC and Sidney Electric. The number one issue is a wiring issue with some transfer devices. These devices are supposed to transfer power from one panel to another. These were either not installed or were improperly wired. The correct boxes have been ordered. This is considered a safety issue as these systems provide for light in the event of a power outage. Our OFCC project manager, Kim Magovac, let us know that she will be leaving OFCC in about two weeks for another position. Kim was invaluable as a project manager and helped us to negotiate and manage a difficult project.

## BOARD COMMITTEE REPORTS

<u>Community Advisory</u> – Ms. Finch said she was able to take part in a tour of Marysville's football stadium as a part of the committee looking at stadium options for Urbana. She said it was a very nice tour.

<u>Finance/Facilities</u> – Mr. Huelsman provided a report detailing work that had been completed including boiler and roof repairs and an asbestos inspection. There is a potential to pass on some costs to Flaherty & Collins concerning North and South as we near the completion of the ownership transfer. We have provided estimates to them concerning potential repairs and heating costs. Mr. Arter pointed out that we have no asbestos in the new buildings.

<u>Legislative/Policy</u> – Ms. Paul reported that the voucher program was still being discussed. A recommendation is expected by the end of the month before the program window opens on February 1, 2020. There was a 300% increase in the number of schools listed as voucher eligible. The state education organizations of BASA, OASBO, and OSBA have come out against the program, noting that private schools are not held to the same standards as public schools, nor are they required to take the same state mandated tests. The Report Card Study Committee wrapped up its work with no formal recommendations

(Motion #0120.13) NEW BUSINESS: It was moved by Mr. Arter and seconded by Ms. Paul to approve the following resolution opposing the State of Ohio EdChoice Scholarship (Voucher) Program:

WHEREAS, the Ohio legislature has recently made amendments which greatly increase the number and availability of vouchers for students to attend private/parochial schools at public tax expense, and

WHEREAS, such vouchers will be available to numerous families and students who have never attended Urbana or any other public schools and for whom state funding has never been provided to Urbana or any other public schools, and

WHEREAS, Urbana's state funding could be unjustly decreased by the amount of the vouchers provided to such families and students who have not and will not attend public schools and others who transfer to private/parochial schools, and

WHEREAS, private/parochial schools accepting students with public tax vouchers would not be required to accept all students but would be permitted to retain their selective admission policies without enforcement of other laws applicable to public schools, and

WHEREAS, private/parochial school students are not subject to the testing standards required of public school students so that the actual performance of private/parochial schools subsidized with public tax dollars will not be known, relative to equivalent public school evaluation standards, and

WHEREAS, this Board believes that the EdChoice voucher program as it currently exists presents serious constitutional issues regarding the separation of church and state and the funding of religious institutions with public tax dollars, and

WHEREAS, the State of Ohio has the constitutional responsibility to secure a thorough and efficient system of common schools, and

WHEREAS, the EdChoice voucher program will have exactly the opposite effect by providing funding to private/parochial schools at the expense and to the detriment of public schools and their students.

NOW, THEREFORE, BE IT RESOLVED by this Urbana City School District Board of Education that this Board reaffirms its commitment to free accessible public schools which are adequately and equitably funded to guarantee a comparable education for ALL children and therefore opposes and respectfully requests the repeal of the ill-conceived EdChoice voucher program of the State of Ohio.

BE IT FURTHER RESOLVED that this Board opposes any funding programs, vouchers or otherwise, that have the effect of diverting public tax dollars from public schools to private/parochial schools.

BE IT FURTHER RESOLVED that the Treasurer is hereby authorized and directed to forward copies of this Resolution to all Ohio state legislators, the Superintendent of Public Instruction and Governor of the State of Ohio.
