Champaign Economic Partnership – Marcia Bailey

Marcia Bailey from the Champaign Economic Partnership addressed the Board. Ultra-Met Corporation has submitted a tax abatement application through the Community Reinvestment Act provision. Ms. Bailey noted this is another opportunity for growth in our community. She presented a summary of recently approved tax abatements in the area. Ultra-Met has been in Urbana for many years and has been working on an expansion project for the past five years. The company needs to expand in order to accommodate new customers, products, and people. The company has purchased the land surrounding its current facility.

The expansion project would enlarge the current building to the north. The approximate construction costs will be \$1.5 million. The total investment for the project is estimated to be \$4.7 million. The project will retain 125 current jobs and add fifteen permanent full time positions and five temporary full time positions and is expected to add \$600,000 to the payroll. The request is for a 100% abatement for fifteen years. The total amount of the abatement is unknown at this time because new tax rates are not yet available.

Will Witten, Ultra-Met Vice-President of Operations, was also in attendance and presented the board with a document on the operations and production at Ultra-Met.

Mr. Arter asked if the request for the abatement was on the additional construction. He also asked if the land that had been purchased would see a change in classification. Finally, he asked if the company would be able to reapply for the abatement at the end of the fifteen years.

Marcia noted that the request would only be on new construction and that the company would not be able to apply again for abatement on that construction; only on anything new. The company can apply for a fifty percent abatement for fifteen years without board approval.

Mr. Arter said his concern is that the district can only collect a set amount and the tax abatements cause the amount to be spread across the rest of the tax base, often to residential homeowners. Marcia commented that this is a tool used across the state toward the betterment of the community.

Mr. Arter said his qualm is in asking others to pay the taxes. He agreed that growth is positive. He said he feels better that the abatement is on new construction and the district will still collect the original taxes on the property. He said he appreciates what the group and the company is doing for Urbana. He wants our community to do well; he just has hesitations about stretching the tax base.

Mr. Engle said he has seen the growth the company has gone through and noted there is a great deal of history with the company.

Ms. Paul confirmed that the abatement was only on the \$1.5 million in new construction, not the total project investment. She said this is a delicate situation. She said she feels we are missing a big piece of information because we do not know the new tax rates. Mr. Thomas asked if the company also did business with local suppliers. Mr. Witten confirmed that Ultra-Met does business with several suppliers in the county and city. He said Ultra-Met rarely sells to the end user of its products. Instead, the products are sold to companies that put them in machines and those machines are then sold to other companies.

A. <u>School Facilities Update:</u> The team is working with our OFCC project manager to reach an agreement on a credit for the landscaping that has not been completed. With that credit, the district will secure a provider in the spring and finish the work. The interior of the Castle has been painted and a vendor is working on cleaning the interior. The windows and finishing work are also being completed. Punch list items at both buildings are being finished as well. Mr. Thiel thanked the board members who were able to attend the Arbor Day event at the PK8 building, highlighting the donation of trees from the Urbana Rotary. Ms. Finch asked if items from North would be moved to the Castle once it is totally finished. Mr. Thiel said records would be moved there and other items would be evaluated as to whether they needed to be kept, sold, or disposed of.

Ms. Finch asked what would be the benefit of waiting. Mr. Thomas noted we do not know the amount of the abatement yet because of the tax rates. Ms. Finch said we are not losing money. Ms. Paul agreed that we should have the same dollars coming in as we do currently. Mr. Thomas said he understands the different points of view. He said we are at a crossroads. We have done this in the

past. The taxpayers have supported our levies. With homes reappraised, individual homeowners may see increases in their taxes. He said he is all for economic development. We also have to consider that the company may consider leaving the area without a tax abatement and we do not want to see a loss of jobs. We need to remember we represent the taxpayers and the community. How crucial is the abatement. We need to know the taxes and if we can negotiate. Mr. Arter commented he has fewer concerns when the abatement is an existing company that will continue paying their current taxes.

Mr. Thomas said we have to try to understand the dynamic in the community. There is a great deal of confusion about whether the school gets more money when home values increase. Ms. Paul said part of her reasoning for wanting to table is to try to have hard numbers available for us to see.

Mr. Thiel said there are numerous ways to address the abatement application. We know they can get fifty percent without Board approval. They have already purchased the property and have spent several years working on this. Ms. Paul said we certainly do not want to see the company leave. It is established in the community, but there has to be a balance for the schools. She said she is uncomfortable voting at this time.

Ms. Paul amended her motion in favor of tabling the consideration of the Community Reinvestment Area Tax Incentive application with Ultra-Met until December. Mr. Arter agreed to second the amended motion.

BOARD COMMENTS

Mr. Arter said he recently read an article in the *Canton Repository* about Canton City Schools serving free dinners to those students participating in after-school sports, clubs, and activities. It is the twentieth school in the state to implement this program. He said Mr. Thomas plans to write something for the paper thanking the public for its support. We never want to take the community support for granted. He said one joy of his in reading the agenda each month is to see the volunteers and the list of donations. He thanked Mr. Bowdle for the information given last month about the House system at the junior high and thanked him for the invitation to the House events. He was glad to see the students of the month at the junior high chosen by House. He said the Arbor Day event was fun. He noted this had been a rough ten days in our district and he offered his condolences to the Rader family and he appreciated the community and the connections brought forth by so many people. He noted the baseball coaches and teachers who gave up time and planned the vigil and thanked Mr. Huelsman, Mr. Thiel, and the custodial staff for their work. He also mentioned Leigh-Ann Simpson and the number of students looking to her for support. He said throughout this he just wanted to hug his son and show kindness to strangers. He said what we do for our kids is important. We all matter. We all have a connection

Ms. Paul said several board members were in Columbus when they received news of the tragedy and they were all glad to see the support our students were given by the staff and by each other. The vigil was put together quickly. These are the things that make Urbana great – the support for one another and making the connections with students. This has been difficult, but our community has pulled together.

Ms. Finch said she was able to make it to the vigil put together by the coaches. She said the Arbor Day event was very nice and it was great to see the kids involved. The sports awards were very good. She noted there were a lot of girls on the soccer team. The Veterans Day celebration was great and she knows the vets enjoyed being a part of the event. She also offered congratulations on the levy passage.

Mr. Engle said while he did not know the young man who passed away, he still cannot imagine going through something like that. He said with Thanksgiving coming up, it reminded him to give thanks

and that we have a great deal to be thankful for. He said being on the board means being transparent, being involved, and doing positive things.

Mr. Thomas said as a Board, we do not want the community to think we take them for granted. He said he received a lot of feedback from friends and he thinks we need to do a better job of communicating between the Board and the community. He said he knew Alex as he had worked with his son. It has been a roller coaster for a few days. He thanked Mr. Thiel for rallying and getting counselors for our children. Ms. Leonard had to put aside her own feelings to help kids first. We have a wonderful, awesome community. Mr. Petty and Mr. Russell pulled together the vigil in a short amount of time and gave the kids an opportunity to just be together and support each other. Several people gathered Monday morning to greet the students as they returned back to school and let them know we are there for them and support them. He said this was a senseless tragedy, but he appreciates all that was done and how everyone pulled together. He also noted the seventh grade football team won the CBC Championship this year and the eighth grade team had a good season as well. He said the high school record did not reflect this season. He said he never saw any classless behavior from our kids. They were always respectful and never gave up or got down on themselves. He said they did not lose sportsmanship and he is proud of them for their efforts. He said that goes for all fall sports. He mentioned he was grateful for the Rotary tree donation and the Arbor Day event. He said he was shocked at how many people came and participated in the Veterans Day event. He said the kids were very excited. He wished everyone a good and safe holiday.

Mr. Thiel said the staff at the high school took care of almost everything. He said the recent passage of the levy as continuing is a great thing. We can put our focus more on educating our students. The first grade recently had its PBL exhibition night. The students did a project on playground safety. He was a member of an expert panel that also included the school nurse, Mrs. Anders, and an engineer. The students asked questions about how to make the playground safer. Other students did a project where they designed and built houses to see if they could be blown over after reading the story of *The Three Little Pigs*. He reminded the board members that there are many activities on the calendar this time of year and several exhibition nights are coming up and to keep an eye on the calendar.
